Creative events:

Sunsari

Conducted creative event (PrEP focused) on May 22th 2024 in Itahari City clinic. A total of 15 FSWs (1.2-13, 1.3-2) participants. It was facilitated by DIC Operator and CBS. There was discussion on importance of PrEP and its continuation, HIV/STI testing, Mental Health. In this event PrEP new 1, PrEP restart 1 and 10 refilled PrEP also 15 KPs done the STI screening and 6 HIV testing.

Morang

Conducted creative event on May 19th 2024 in Biratnagar Field Office. A total of 13 female (1.2-5, 1.3-8) participants participated in the event. It was facilitated CBS, PN and Field Supervisor. There was discussion on importance of PrEP and its continuation, HIV prevention & treatment. In this event 1 of the participants were screened for STI/HIV and 1 client are PrEP new.

Jhapa

Conducted creative event on 26th May, in Birtamode City clinic. A total of 12 (FSWs) were participated in the event which was facilitated by HA, DIC, CBS & P.N. Discussion was done about the importance of PrEP its advantages, sexually transmitted Infections (STIs) and its effects. In the program, happiness was shared among the participants in the occasion of Nepali New Year 2081. In this event,8 Kp tested for HIV & STI, 4 KP started PrEP & 1 restarted. Also, 8 KPs were screened for STI & 2 of them were diagnosed.

Monthly joint inter-Network meeting:

• In this period conducted jointly district level coordination meeting at Hotel Triyuga, Itahari Sunsari on May 3rd, 2024. In the meeting DAO of Sunsari Mr. Jaya Narayan Acharya was chief guest along with Sunsari Health Administrator HIV focal person of district, ART Counselors, Health coordinators of 12 Palikas, chiefs and representatives of NGOs/INGOs working in HIV program in the district. There was sharing of EpiC project activities in the district along with current status of HIV in national, province and district. Goal of National HIV Strategy Plan by 2026 and by 2030 and activities conducted in the district to achieve 95-95-95 and current status of ART services and

status in Inaruwa and BPKIHS in the district. Along with there was discussion on issues and challenges of HIV program (CABA support deduction in Koshi province, shortage of reagents for VL testing, supply of kits and medicine from province), issues of identification card of PLHIV for enrollment in Health Insurance and other programs of government.

- In this period participated in the workshop of online child sexual abuse prevention organized by Voice of Children Nepal at Inn Tourist Hotel Itahari on May 20th, 2024. There was presence from Karuna foundation, Maiti Nepal, Prayash Mahila Samuha, Mahila Sahayogi Samuha, Jagaran Aarogya Samuha, Shramik Mahila Samuha, Youth Development Center, Ilaka police office, Itahari Municipality. In the meeting there was orientation on online child sexual abuse methods, causes, preventive measures and Toll-free numbers for reporting of such events.
- In this period participated in the stakeholders meeting in Dharan Municipality Office on May 24th, 2024 organized by Dharan Positive Group. In the meeting there was presence of Mayor, Ward president, ward member along with NAP+N, Prayash Mahila Samuha, Human Welfare Society, Mahila Sahayogi Samuha, AMDA Nepal, Richmond Fellowship. In the meeting there was sharing of activities conducted by DPG, status of HIV clients and ID Users in Sunsari district and role of local government to achieve national goal by 2026 and 2030. Also, allocation of budget for HIV and ID Users for program in upcoming fiscal year 2081/82.
- In this period participated in the Sharing Meeting at Biratnagar Metropolitan Hall organized by Biratnagar Metropolitan Health section on May 27th, 2024. In the meeting there were participants from the all NGO/INGO representatives of Biratnagar along with Morang health office Incharge and health section staff of Biratnagar metropolitan. There were details sharing of activities of metropolitan in 080/081, coordination activities with the help of NGO/INGO. Where metropolitan asked the what kind of coordination/help can be done by different NGO/INGO in coming FY 081/82. Every NGO/INGO represent their thoughts related to it. We also proposed for the S & D training to FCHV of Biratnagar metropolitan.

Viral Load campaign

- Morang: In this period 25 viral load sample collection done and 56 viral load report received.
- Sunsari: In this period 32 viral load sample collection done and 63 viral load report received
- In Illam, altogether 15 viral load sample was collected from Illam ART in coordination with AMDA Nepal Illam, CCC and was sent to Koshi hospital.
- In Jhapa, 42 viral load sample was collected from Mechi ART center & sent to Koshi Hospital.

• In this period Psychosocial Counselor Nisha Dahal visited itahari city clinic on May 7th and 22ndrespectively. She participated in the creative event and support group meeting to support and address in mental health issues and problems.

Monitoring visit by GoN

• In this period monitoring visit was done.

Provincial / Other GoN meeting:

• In this period monitoring visit was done by Acting Director of Social welfare Society Mr. Dipendra Pant, Team leader Dr. Yogendra Shah and Chief Administrator Mr. Sudesh Regmi from May 17th to 19th, 2024. The team visited EpiC Project field Office Itahari. There was sharing of EpiC Project activities conducted by AMDA Nepal in the district, with targets and achievements, discussion on issues, challenges and best practices. After that the team monitored the registration process, Lab room, counseling room and services provided from these rooms and had interaction with Lab staffs, Clinical Helper, case manager on Viral load testing, STI diagnosis and treatment, cold chain maintained, waste management process.

After that they had a meeting with Health section of Itahari Municipality (Chief of Health Section Mr. Dinesh Chaudhary and Vaccine focal person Mr. Rohit Timisina), there was discussion of EpiC project activities in the Itahari Municipality. Mr. Chaudhary express that EpiC project is working well in the district with timely reporting and sharing of EpiC project activities during monitoring visit and coordination and sharing meeting and coordinates and leads HIV program in the district and local level.

Monitoring team also visited district hospital Inaruwa and had interaction with the Hospital administration and ART center team on HIV program and support activities of EpiC Project in ART center. Hospital mgmt. team has responses EpiC project roles is crucial in effective implementation of HIV program in the district in case detection, ART enrollment, ART adherence, viral load testing, EID sample collection, HR support for regular service delivery and timely recording, reporting and logistics support as per need in HIV program also supports in regular meeting and review of HIV program. So EpiC project is playing vital role in ART service delivery from district hospital.

Team also visited Birtamod city clinic there was sharing of the activities of the program as well as challenges and ways to overcome them were discussed with field staffs. Also, team had interaction with key beneficiaries on satisfaction of services delivered by EpiC Project in the district from EpiC Project along with feedbacks and suggestions from beneficiaries were taken for further improvement the project.

Team also visited Biratnagar field office and had interaction with field staffs on project activities in the district with issues and challenges and areas to improve and address in upcoming days for quality of services delivery and sustainability of HIV program.

Overall impression of SWC visit was fruitful and meets their expectations on EpiC project activities and linkages with local government for sustainability of HIV program as they expected from project.

Monthly ART center Meetings

• Koshi ART Center

Quarterly ART meeting was conducted at Koshi ART center on May 21st, 2024. In the meeting, there was presence of Emergency Incharge, Lab Incharge, ART Counselor, Province, PC, M & E officer, HA-ART, CBS, PN from EpiC Project along with Program officer of Sparsha Nepal and Richmond Fellowship. In the meeting there was sharing of findings of current status of HIV/AIDS, National Strategy to meet 95-95-95 by 2026 and end AIDS Epidemic by 2030, current achievement on 95-95-95 in Nation, province and district level and current status of Koshi hospital. Along with need to increase in follow up for IIT cases, need to increase baseline test of all clients in a regular basis 6/6 months for early detection of early detection of AHD.
